4. Calibration

Span calibration

You can calibrate the detector using button (No. 4) on the pcb board to refer to page 5.

Please set output of the detector as each range's output touching No. 2 and No.3 terminal with a tester after stabilizing output of sensor for 30 to 60 sec. after inserting each standard gases to the sensor part of the detector.

AWARNING

Do not Fresh Air Calibration unless you are certain you are in fresh, uncontaminated air; otherwise, inaccurate readings can occur which can falsely indicate that a hazardous atmosphere is safe. If you have any doubts as to the quality of the surrounding air, do not use the Fresh Air Calibration feature. The calibration check is required to verify span accuracy. Failure to follow this warning can result in serious personal injury or death.

AWARNING

If the LOW or HIGH alarm activates, leave the contaminated area immediately; the ambient gas concentration has reached the preset LOW or HIGH alarm level.

Failure to follow this warning will cause over-exposure to toxic gases and persons relying on this product for their safety could sustain serious personal injury or death.

NOTICE

We recommend calibration once every six months, at least once a year. Sensor's output going down as time goes by; measurement error will increase.

Calibration is crucial for the sensor performance and persons relying on this product for their safety.

6. Notice for user

- 1. SI-100C is basically for indoor use. You need to install additionally rain cover to protect the detector from rain if you want to install the instrument outdoor.
- 2. Install the detector to the location within 30cm from the bottom (If heavier gas than air, e.g. LPG)
 - Install the detector to the location within 30cm from the ceiling (If lighter gas than air, e.g. LNG)
- 3. Make sure that you have to use cable glands(explosion proof) or Sealing fitting (explosion-proof construction for internal pressure) to prevent inflow of external gases if you want to install the detector in explosion district.
- 4. SI-100C can be used with present any indicators and PLC using analog output (4-20mA)
